 Notice of Improvement Hearing
 Township of Hamburg
 Livingston County, Michigan**

TO: THE RESIDENTS AND PROPERTY OWNERS OF THE TOWNSHIP OF HAMBURG, LIVINGSTON COUNTY, MICHIGAN AND ANY OTHER INTERESTED PERSONS.

PLEASE TAKE NOTICE that as a result of Petitions from property owners within the township signed by the record owners of land whose footage constitutes more than 50% of the total (approx. 1,690 linear feet) of the hereinafter described **Norene and Peary Drive - Road Maintenance Special Assessment District**, the Township Board of the Township of Hamburg proposes to re-establish the district to provide: up to three (3) gradings per year as necessary; up to 60 cubic yards of road quality (22A) gravel annually as necessary; snow removal - up to eight (8) times per year, as necessary, for the removal of four (4) inches or more of accumulation; and sanding up to eight (8) times per year when icy conditions require.

PLEASE TAKE FURTHER NOTICE that the District within which the foregoing road maintenance services are proposed and within which the cost thereof is proposed to be assessed consists of the lands identified in the map attached to this notice and are more specifically identified by the following permanent parcel numbers:

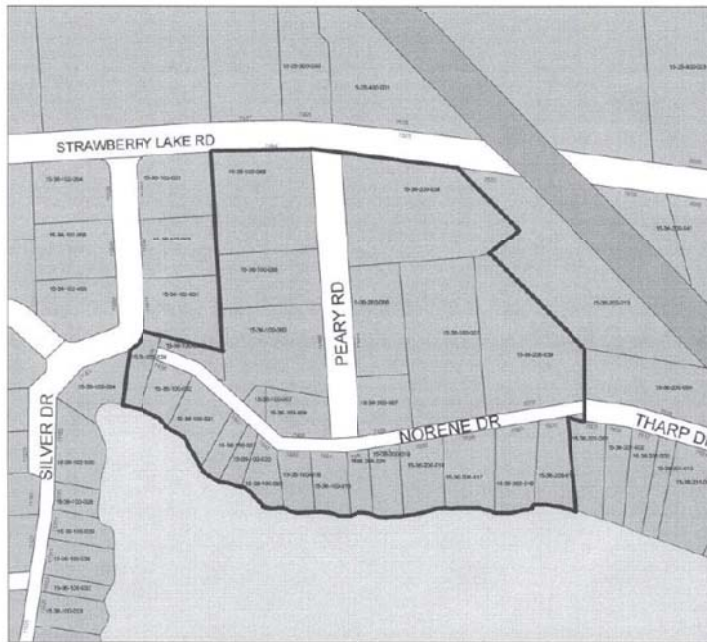
